#### I – Introduction

Indira Gandhi College of Nursing is located in the heart of Kochi city. With the motto "knowledge with mission" the management aims to provide quality Nursing Education to the highest level to be a part with global standards. The college has excellent faculty and good infrastructure facilities. The faculty accepts its responsibility in helping the students to develop pride in their profession besides keeping them abreast with current knowledge and profession trends for a successful career ahead.

The college of Nursing included in this prospectus offer B.Sc.Nursing Degree program of 4 year duration as specified by Kerala University of Health Sciences (KUHS), approved by Indian Nursing Council & Kerala Nurses and Midwives Council.

#### II – Purpose

The main purpose of this course is to provide an educational programmer through which the graduate will be prepared to assume responsibility in the primary, secondary and territory care of people as professional Nurses. It is expected that graduates are capable of teaching and supervising appropriate Nursing and healthcare in different setting and participate in the administration of Nursing Services and Education.

# III – Eligibility for Admission

# 3.1 Academic:

(I) Candidate who have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent Examination recognized by any of the universities in the state of Kerala with 50% marks in Physics, Chemistry, Biology and English put together are eligible for admission.

(ii) Relaxation in marks

- a. Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the state of Kerala with total annual family income up to Rs.4 lakhs will have relaxation of 5% marks. The Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying examination.
- b. Those candidates claiming relaxation of marks shall produce necessary certificates under Management Quota.

(iii) Eligibility certificates: Candidates who have passed their qualifying examination from places other than state of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

# 3.2 Age:

(i) Applicant should have completed 17 years of age on the 31<sup>st</sup> December. No relaxation of the minimum age will be allowed.

(ii) Self attested copy of relevant page of school record namely SSLC/ICES/CBSE/ certificates showing the date of birth/copy of birth certificate should be furnished along with the application in proof of age.

# IV – How to apply

4.1 Issue of application forms: The application forms and information brochure can be obtained from the college. Prospectus on payment of Rs.600/-(Rupees six hundred only) in cash.

4.2 Submission of application form: The completed application form shall be submitted to the college concerned along with copies of necessary documents.

### **Other enclosures:**

(i). A self addressed envelope (25x12 cms size) with Indian postage stamp worth Rs.5/- affixed thereon with each set of application form.

- (a) Application not accompanied by documents in proof of claims made therein will be summarily rejected without further intimation.
- (b) Candidates are requested not to enclose original of any certificate along with the application. Self attested photocopies need only be enclosed.

### (ii) Important

- (a) Documents/Certificates furnished after submission of the application will not be entertained under any circumstances.
- (b) No opportunity will be given to incorporate any details or documents after the submission of application expect for those whose results are not declared before the last date of the submission of application.

### **V- Preparation of Merit list**

5.1 Merit list: Merit list of eligible candidates will be prepared by the college on the basis of marks obtained in the optional subjects (Physics+Chemistry+Biology and English) for the qualifying examination.

5.2 Resolution of ties while ranking: In the case of tie in the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will count. If a tie still exists, the marks of English will count. If there is still a tie the age of the candidate will be taken into account, the elder will be preferred to the younger.

5.3 Validity of the merit list: The published merit list will be valid till 31.10.2018 or the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.

5.4 Inclusion in the merit list will not entitle the applicant eligible for admission to the cause, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the prospectus.

5.5 Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

# VI- Selection of procedure

6.1 Selection of the candidate will be done by the college from among the candidate who have applied in the college based on the marks obtained in the optional subjects(Physics, Chemistry, Biology and English) secured in the qualifying examination. Call letter for interview will be sent to each candidate from the college and oral interview will be conducted.

# **VII- Admission & Payment of fees**

7.1 The selected candidates will be informed about the date and time of admission.

7.2 The students shall pay all fees of the 1<sup>st</sup> year of the course at the time of admission which will not be refunded. Fee stipulated by the fee regulatory committee/Govt. of Kerala is as follows:

Tuition fee Rs 63,500, other fee Rs17,000, Caution deposit(Refundable) Rs. 10,000/ and other fees due to statutory bodied(KUHS,KNMC &INC) as and when notified, Hostel fee Rs. 30000/-

7.3 If any candidate discontinues the course, after closing of admission(30/10/2018 for 2018-19 the candidate has to pay the full fee of the remaining course (4yrs). Transfer certificate will be issued only after payment of the above amount. Also Legal proceedings will be initiated against student/parent for realization of full amount of fees.

# VIII – Special Instructions

(a) **Ragging:** Ragging in any form is strictly prohibited in the college. Hence any student who indulges any form of ragging will be subjected to penal action as per provisions of law. Also the student will be expelled from the college as detailed in the law concerned and as per the Honorable Supreme Court of India directions in this regard.

- (b) **Use of mobile phone:** Use of mobile phone by students are not allowed in the campuses and hostels of the college. Any violation of this prohibition will lead to stringent disciplinary action by the college authorities.
- (c) Any other items not specially covered in this prospectus will be decided by the undersigned, and his decision shall be final.

### IX – Undertaking regarding noninvolvement in ragging
